# I. Definitions:

# Resorts of Distinction:

Resorts of Distinction (ROD) is an affiliated organization with Benjamin's Beaver Creek for the purpose of these member rules this definition means either or both.

#### Member:

A person or the spouse of a person who has purchased a membership.

# Family Member:

An unmarried son/daughter, 18-21 (up to 22<sup>nd</sup> birthday) years of age who lives in the member's household. A student who is away at school, but otherwise meets this definition is considered a "family member".

# Guest/visitor:

Any person, other than the spouse of a family member, who visits or accompanies a member and who is granted temporary admittance to the resort facilities.

# Definition of A camping unit:

A camping unit is defined as:

- 1. A car and two tents
- 2. A motorhome (see note)
- 3. A truck/car and trailer
- 4. A truck and 5<sup>th</sup> wheel trailer
- 5. A truck/car and tent trailer
- 6. Park pride models

Note: A van or truck-camper equipped for sleeping, cooking and/or otherwise self-contained is considered a motorhome.

### Full-hookup campsite:

A full-hookup campsite is defined as a site with electric, water and sewer hookups.

# Partial-hookup campsite:

A partial-hookup campsite is defined as a site with water and electric hookups.

# Self-contained campsite:

A self-contained campsite is defined as a site without utilities. A picnic table may be present, but not guaranteed.

#### Facilities:

All personal and real property owned, leased or operated by Benjamin's Beaver Creek or its affiliates, including, but not limited to, the land, improvements, equipment and amenities within the boundaries, of the resort.

# Reciprocal Privileges:

Reciprocal privileges are available. A list of resorts participating in the reciprocal program can be obtained at the Welcome Center. Please see your member representative to see what your membership offers you.

### II. GENERAL RULES:

#### Member Rules:

These rules may be modified, amended or deleted as Benjamin's Beaver Creek deems appropriate. The following rules serve as guidelines, and are not all-inclusive. It is the intent of Benjamin's Beaver Creek to make known all rules which will ensure the maximum enjoyment of your membership. It is member's responsibility to be aware of all required rules and regulations. Updates can be found in registration office and online on our website at <a href="https://www.benjaminsbeavercreek.com">www.benjaminsbeavercreek.com</a> (Go to Members tab, click on Member Info and then click on Member Handbook.

# Copy of Rules:

A copy of these rules will be available at registration office.

#### MEMBERSHIP CARD:

Membership cards will be issued to the primary members. Membership cards may not be loaned to anyone except as provided in these rules. A second form of I.D. may be requested upon entry. Misuse of membership card will result in its confiscation. Appropriate action will be taken. Qualified family members may purchase a card for \$25.00. The cards will give you access to the security gate at the entrance. Each member card is encoded and designated to a particular member.

#### LOST CARD:

A replacement fee of \$25 will be charged for lost membership cards.

#### Conduct:

Members, guests and visitors shall conduct themselves with decorum while on the resort premises and will not indulge in loud or boisterous conduct. In order to promote the safe and harmonious enjoyment of Benjamin's Beaver Creek by everyone, all persons entering these premises are expected to abide by the following general rule of conduct and agree to do so as a condition of entering these premises:

NO PERSON SHALL ENGAGE IN DISORDERLY CONDUCT OR CONDUCT WHICH INFRINGES UPON THE PEACEFUL ENJOYMENT OF THE PREMISES BY OTHERS. SUCH CONDUCT INCLUDES, BUT IS NOT LIMITED TO, ANY BEHAVIOR OR ACTIVITY WHICH CREATES, OR TENDS TO CREATE, AN UNSAFE OR HOSTILE ENVIRONMENT. If, in Benjamin's Beaver Creek's sole judgment, any person who violates this general rule of conduct, suspension or expulsion from membership, expulsion from premises, or any other action Benjamin's Beaver Creek deems appropriate.

#### SUSPENSION AND FORFEITURE OF MEMBERSHIP:

If, for any reason, the membership is terminated, Benjamin's Beaver Creek is not legally obligated to reinstate said membership.

Benjamin's Beaver Creek membership is subject to suspension or forfeiture without reimbursement of payments and dues for any of the following reasons (not all-inclusive):

- 1. Non-payment of any fee, charge or other obligation owed to Benjamin's Beaver Creek;
- 2. Violation of Benjamin's Beaver Creek rules regulation the use of resorts;
- 3. Abuse of any nature of Benjamin's Beaver Creek employees, members, equipment or facilities;
- 4. Commission of a criminal offense on Benjamin's Beaver Creek property or facilities;
- 5. Disorderly conduct on Benjamin's Beaver Creek property or facilities.

#### RESORT EMPLOYESS:

Resort employees are not subject to the individual direction or control of members. No member or guest shall reprimand, threaten, strike, mistreat, harass, or verbally abuse any resort employee at any time. The specific direction and control of resort employees is vested in Benjamin's Beaver Creek and its duly authorized management. If you have any concerns or issues please contact park management.

Illegal drug use policy:

Benjamin's Beaver Creek promotes a drug free environment. Member, family member, or guests found to be under the influence or in the possession, or use of an illegal substance, as so defined in Michigan Penal Code or Michigan Health and Safety Code, will have the membership revoked without appeal.

#### Alcohol:

Alcohol will not be consumed by minors under age of 21 under any circumstances. Any alcohol-related disturbance or incident will be treated as a serious offense. Benjamin's Beaver Creek RESERVES THE RIGHT TO PROHIBIT THE USE OF ALCOHOLIC BEVERAGES AT ANY FUNCTION OR ACTIVITY AND RESTRICT THE USE ON THE RESORT AS DEEMED APPROPRIATE BY MANAGEMENT. Open or exposed alcoholic beverages will not be taken into the store, any office or area where it could become a nuisance to others. Driving with an open alcoholic container, and/or under the influence of alcohol or drugs is prohibited.

#### SMOKING:

Smoking under the age of 18 is prohibited.

Certain areas have been designated as non-smoking; signs are posted at these locations. This policy is strictly enforced. Please dispose of cigarettes properly.

#### CHILDREN:

Members are totally responsible for their children, including their guest and their guest's children. Children under 18 years of age may not use the resort unattended without an adult family member being present. Curfew for children under 18 years of age is 10:00pm, unless otherwise posted. They must be physically in the member's campsite. Any member's minor children who elect to stay in another member's campsite for the night must have both members' permission. Children ten (10) and under must be accompanied by an adult at all times. It is the responsibility of the member their guest to assure that all children are supervised, and not found to be in violation of curfew. Any violation of the above could result in the suspension of the member's membership privileges.

### FIREARMS:

The possession of firearms or other weapons in the park is prohibited.

#### LITTER:

All persons must dispose of all trash, cigarette butts and litter in the containers provided. Members and guests are responsible for keeping their campsite clean, neat and litter-free at all times.

# Soliciting: expression of views:

Benjamin's Beaver Creek was designed to be a place for safe family enjoyment where members and their guests could visit and experience a carefree stay. In order to help facilitate this objective, the following guidelines shall be enforced.

Members may not advertise their business while in the resort. This includes but is not limited to magnetic signs, "for sale" signs, business information painted on vehicles, and items displayed in such a way to entice buyers (i.e., garden art, lawn ornaments, crafts hung on awning or placed in windows of the camping unit in such a way to entice buyers is not allowed). Advertising employment opportunities is also not allowed. Management will have the sole decision of what constitutes items displaced for sale or personal gain. Members who wish to sell items may do so at activity sponsored functions. Benjamin's Beaver Creek assumes no liability or responsibility for any item offered for sale in the resort.

As a private property, Benjamin's Beaver Creek reserves the right to determine which actions are appropriate for this setting. In light of this, it has been decided that at no time shall any member visually display or verbally promote any political, religious or cultural view.

#### **VEHICLE DAY PASS:**

When a member is using Benjamin's Beaver Creek for the day, they are allowed their arrival vehicle plus two (2) guest vehicles. Any vehicle after this is required to pay \$5.00 per vehicle. (Please be reminded that including your own family, there may be a maximum of ten (10) people in the resort under one membership. Each extra guest after 10 people in your party is required to pay \$5.00 per person.

If you are here for day use only, members and guests are required to park in the designated day use parking areas. Due to the limitation on sites during busy holiday weekends those who are already checked in a site may not park their vehicles in another site. However, you may use the Day Use parking areas provided. (Those who park in a site will be asked to remove their vehicles.)

# Additional Day Pass:

Once a member has their third vehicle in the resort, no additional vehicles will be allowed. It will be the member's responsibility to make sure that their departing guests leave their passes at the office so that future guests are allowed to enter.

Do not overcrowd your site with extra vehicles. Vehicles not parked on RV portion of site will be asked to move to a designated parking area. Do not use an empty site to park vehicle.

# Golf Carts/ATV off road vehicles:

If you choose to tow in your personal golf cart for your visit, please be aware of the following rules. You must have current insurance, registration and driver's license. There are no open containers allowed. You must display current Benjamin's Beaver Creek Vehicle Pass. Fees may apply.

Golf carts must use the same roads and streets that are provided for regular vehicles and are not allowed to drive across grass sites or other areas that are not part of normal vehicle traffic. Operators must follow all Sate of Michigan Vehicle Code requirements.

# Group camping/special functions:

Due to many different needs and requirements, members must contact the registration office for specific details, fees, and procedures. All facilities will be by reservation only and only at a time when it will not interfere with resort and member activities. Group camping guidelines and information can be picked up from the registration office.

# Vehicle Operators:

The resort operates under the State of Michigan Vehicle Code. Only persons holding valid and current driver's licenses and proof of insurance are permitted to operate motor vehicles in the resort. This includes golf carts.

# Resort speed limit:

The resort speed limit is ten (10) miles per hour in all areas. This includes golf carts, bicycles, roller blades, skates and scooters. Please use caution.

# Vehicle Usage:

Vehicle usage may be restricted in the resort, at time, due to certain activities and/or functions throughout the resort. This will ensure the safety of children and others. Prior notification of these events will be provided.

# Snowmobiling, golf carts, atvs, bicycles, skateboards:

Snowmobilers are allowed in designated areas only. NEVER ON THE SURROUNDING GOLF COURSE. This is subject to change if speed and area rules are disregarded, and the trails are misused. Golf carts and ATVs and other wheeled vehicles must remain on the pavement at all times, MUST NEVER BE ON THE GOLF COURSE PROPERTY AT ANY

TIME AND MUST NOT RIDE AROUND ON DIRT OR GRASS SURFACES ON THE RESORT. See Front Desk for an unlicensed vehicle pass. Fee may apply.

Bicycles, skate boards, golf carts and all other wheeled vehicles are not allowed on sidewalks, patio or inside buildings at any time.

#### Abandoned vehicles in sites:

Vehicles, RV's or other property will not be left unoccupied and unattended in a campsite overnight. Members are prohibited from placing a camping unit in a campsite and leaving the resort for the sole purpose of saving a site for weekends, holidays or other functions or reasons. Members who leave their vehicles, RV's or other property unattended will be fined \$25 for each night their vehicle, RV or other property is left unattended and are subject to having their membership suspended.

#### Vehicle Passes:

All vehicles, including trailers, motor homes, additional vehicles, tents, tow or towed vehicles will have a vehicle pass. This pass will be displayed in such a manner that it can be easily read from the outside without disturbing the occupants regardless of the time of day or night.

#### Sewer hose connections:

All sewer hoses that are attached to full hook-up sites must be equipped with an adapter to prevent the sewer hose from slipping down the sewer line and plugging the resort sewer system. Members must supply their own adapter. Members are responsible for re-capping their sewer connections upon departure.

#### Campsite Cleanup:

Members are responsible for keeping campsites in a litter-free, clean and neat condition, including removing pet feces. If it is necessary to send in a cleanup crew to a campsite after a member or guest leaves, the member will be subject to cleanup fees. Cleanup fees must be paid prior to allowing the member to return access to the resort.

### Sewer Dump/Air Station:

A sewer dump station is located near comfort station. Rules governing the dump/air station use are posted nearby.

# Reporting Problems:

Members may report any maintenance or housekeeping problems to any staff member 24 hours a day. Our staff is here to help you have an easy-going, carefree and safe vacation. Members are prohibited from performing repair work to park equipment or property.

# Emergency Precautions/Evacuations:

During periods of extreme fire hazard or other emergencies, special precautions or evacuation may be ordered by the resort management or by the local fire department. All members and guests shall immediately comply with such orders. In the event of a severe emergency, the resort may be temporarily closed.

#### **Quiet Hours:**

The hours between 11:00pm and 7:00am are considered "Quiet Hours" at the resort. During these hours, there will not be any loud music, noise or boisterous activity, annoying bright lights or operation of any type of generator or other types of power equipment.

NOTE: At all times, radios/T.V.'s or entertainment equipment: As a courtesy to your neighbors, we ask members and visiting guests to keep the level of music to your campsite area. Member will be asked to turn down music or loud noise that is heard from the street in front of your campsite or vacate the resort.

# Messages:

Benjamin's Beaver Creek is not responsible for accepting or forwarding messages to members or guests. It is the member's responsibility to ensure that the operations center is aware of the proper site numbers (or the exact location if you are in unmarked dry sites).

#### Attachments:

No member or guest shall attach any apparatus or accessory to trees, shrubs, buildings or other Benjamin's Beaver Creek property including, but not limited to: clothes-lines, lights, tent-lines, bug-zappers, hammocks, clothes, swimsuits or similar items. We ask that you please keep clothes-lines neat, orderly and out of sight.

#### Pets:

Benjamin's Beaver Creek will enforce a three (3) domestic pet limit. Domestic pets will be the only pets permitted in the resort. All dogs must be confined on a leash or tethered at all times. Leashes must not exceed six (6) feet in length. Pets, including cats, are not allowed to run free at any time. Pets are not allowed in communal buildings, bathroom facilities, restaurant or store, with the exception of Guide Dogs. Members are responsible for cleaning up after their pets. Noisy or vicious animals are not allowed. ALL PETS WILL HAVE PROOF OF CURRENT VACCINATIONS AND LICENSES, AS REQUIRED BY LAW. Members whose pet bites any individual in the resort will be liable for any medical or legal expenses incurred. Those who fail to assume responsibility for their pets could have membership suspended or revoked and will have

their pet permanently banned from the resort. Pets will not be left unattended in any RV, vehicle, park pride model or trailer during hot or cold weather due to safety and health reasons.

Pet enclosures will be permitted if they are kept neat and clean. Management reserves the right to revoke this privilege.

Member will be asked to remove dogs showing any sign of aggression immediately.

#### Contact with wildlife:

From time to time, due to the location of our facilities, you may come into contact with wildlife. Please refrain from feeding or disturbing them. Please notify our ranger department or management of such contact. DO NOT LEAVE YOUR FOOD OUT OVERNIGHT.

# Campfires:

All campfires must be contained within a fire ring on your site. Wood is the only substance permitted to be burned.

# Sewage waste disposal:

Sewage will be emptied or drained into the appropriate receptacles at the full-hookup site or at the sewer dump station. Draining "graywater" or sewage on the ground or in any stream bed, water or lake is strictly prohibited. Sewer hoses will not be washed, cleaned, or rinsed in any stream, lake or creek. Violation of these rules will result in a fine, suspension and/or revocation of membership.

### Facility Closures:

Please note that from time to time, it may be necessary to close certain amenities, facilities or areas for refurbishing, seasonal conditions or safety concerns.

# Rules are Subject to Change:

All rules are subject to change without notice.

#### Additional Site:

Anytime a member requests an additional site, a guest fee will be applied. This includes park models. Cabin keys must be turned in and cabin vacated by 11am.

#### Adult Areas:

Certain age restrictions apply to specific areas and times to the adult center, adult pool and Jacuzzi. Shoes and shirts are required in the adult center at all times.

#### Fees:

Benjamin's Beaver Creek reserves the right to charge for incidental services and amenities. Such charges are subject to change without notice.

# Release of Liability:

In the membership agreement, you agree to indemnify and hold harmless Benjamin's Beaver Creek with respect to all injuries, property damage or other loss suffered or caused by a member, a member's family, guests, or pets, including attorney's fees incurred in connection with any claim made as a result of such injury, property damage, or loss.

Members assume a degree of risk when using facilities and amenities and participating in activities. The resort and its staff shall not behold liable in such instances. Members assume liability for damages that may occur through their own negligence or the negligence of their guests, and shall not hold the resort accountable for any such occurrence. Benjamin's Beaver Creek is not responsible for any legal disputes among members that result from any occurrence that happens on Benjamin's Beaver Creek property.

### iii. Reservation information:

#### Holiday weekend usage:

Due to the popularity of major holiday weekends, only one campsite or park model per membership.

#### Reservations:

Reservations are made according to the space availability. A reservation should be made for the actual date of arrival. Members may have two reservations at any one time. Reservations may be made up to **60 DAYS IN ADVANCE OF THE SCHEDULED ARRIVAL DATE.** For reservations call (local) 989-732-2459 or (toll free) 877-295-3333 seven days a week from 9:00am to 5:00pm. Reservations office is closed Thanksgiving Day, Christmas Day, and New Year's Day.

#### PAYMENTS:

Your account must be current with our registration office at least 72 hours in advance of your Benjamin's Beaver Creek arrival. If we do not have confirmation that your account is current, you could run the

risk of having your reservation cancelled and being turned away at the gate.

#### LENGTH OF STAY:

Depending on space availability, members may use the resort for a maximum of 14 consecutive nights and must depart from the resort. Members must be out of the resort for as long as they were in. (For example: a member who stays in the resort for five nights must be out for five nights; in for 10 nights, out for 10 nights.)

### MEMBER DAY USE:

Any member in good standing may use the resort facilities on a daily basis. On weekends and holidays, members may not use or park in full hook-up sites. Members will park in designated parking lots or dry sites only. Note: a weekend is Friday and Saturday, **WITH THE EXCEPTION OF HOLIDAY WEEKENDS**.

#### FAILURE TO CANCEL RESERVATION:

Members who fail to cancel their reservation or guest reservation at least 72 hours in advance will forfeit the remaining night's reservation and receive a "No-Show" fee. You may call or email at <a href="mailto:reservations@benjaminsbeavercreek.com">reservations@benjaminsbeavercreek.com</a> to request a cancellation. "No SHOWS":

A "No Show" is a reservation, which is not kept by midnight of the reservation date. Two "No Shows" could result in a 30-day suspension of membership. "No Shows" occur when a member fails to cancel a reservation 72 hours in advance. A "No Show" will result in the loss of remaining night's reservation. In the event that the reservation was cancelled, a cancellation number will be required as proof of cancellation. Again, you may call the registration office or email <a href="mailto:reservations@bensbeavercreek.com">reservations@bensbeavercreek.com</a> to request a cancellation of your reservation.

#### CHANGING A HOLIDAY RESERVATION:

Due to the popularity of major holiday weekends, once a reservation is confirmed, it cannot be changed to a later date.

#### OCCUPANCY:

No permanent occupancy is permitted. Membership is designed for leisure and vacation activities and day use. The resort may not be used as a base camp for transient persons or workers. Transient is defined as persons not having a permanent or fixed address. Members must maintain a permanent residence outside the resort. Members using a post office box for an address must show proof of residence.

# IV. PARK PRIDE MODEL UNITS RULES:

#### Rental Cabins:

We are fortunate to have beautiful fully furnished cabins that are owned by members called The Beaver Creek Condominiums Association. As a member, you will receive 50% rates, excluding major holiday weekends. There is a two night minimum stay plus a cleaning fee.

### Availability:

Park pride model units are available to members owning the appropriate memberships with park pride model privileges.

# PARK pride MODEL UNITS:

There is a two (2) night minimum stay required on all weekends. However, during the week, Sunday through Thursday, with the exception of holiday weekends, these units may be available for one night at a different rate. Management reserves the right to impost a security deposit when deemed necessary, without any prior notice.

# PARK PRIDE MODEL UNITS FOR GUESTS:

Members may reserve one park pride unit for guests, except on holiday weekends. Non-member guests must pay the \$83/night.

# Check-in/Check-out Time:

Check-in time is 3:00pm (no early arrivals). Check out time is 11:00am (no late departures). However, if you like to extend your stay, please check with the reservations department for more information. Late departures will be charged an additional one night rental fee and/or forfeiture of key deposit.

#### FAILURE TO CANCEL RESERVATION:

Members who fail to cancel their park model reservations at least 72 hours in advance will forfeit the remaining night's reservation and be charged one night's maintenance fee at the current nightly rate, to be paid prior to next visit.

# "No Shows":

A "No Show" is a reservation, which is not kept by midnight of the reservation date. Two "No Shows" could result in a 30-day suspension of membership. "No Shows" occur when a member fails to cancel a reservation 72 hours in advance. A "No Show" will result in the loss of remaining nights' reservations and a charge of the nightly

maintenance fee, to be paid prior to next visit. In the event that the reservation was cancelled, a cancellation number will be required as proof of cancellation.

#### FURNISHING IN UNITS:

Park pride models are fully furnished except for bed linens, towels and personal items, such as soap, shampoo, etc.

#### DAMAGE TO UNITS:

Damaged and missing items will be repaired and replaced, at the sole expense of the member, to be paid in full prior to next visit. Damages must be reported immediately upon arrival to registration personnel, otherwise it is understood that the cabin is in good condition and that there are no damages to report. After departure any damages to the cabin will be billed to the member.

# Pets in Park pride models:

Certain park pride models have been designated as "No Pet" units for members. These units are available on first-come, first-serve basis. No pets are allowed in these units at any time.

Members who decide to bring their pets to pet-permitted park pride models can be billed a "pet clean-up fee" to cover the charge of cleaning and disinfecting the park pride model if it is determined, that the member's pet has created an additional workload on the housekeeping staff. This fee may exceed the park pride model maintenance fee. Members must pay the fee prior to their next visit.

# V. Family Member/Guest Information:

#### Family member use:

Membership is designed and intended for use by the member, spouse, and the immediate family. Family members who are unmarried, 18 through 21 years of age living in the same residence as member or away at school may use the resort without being accompanied by the member upon presentation of a valid membership card, proper identification, and signed permission slips from the member. All permission slips must list all guests and a phone number where the member can be reached. Permission slips are subject to telephone verification. A new permission slip is required each visit.

# Dual Memberships:

A dual membership is shared by two unmarried people. A dual membership is treated just like a traditional membership in terms of all rules and regulations. Members are prohibited from having dual memberships for the purpose of circumventing the system. A member

is always a member and cannot become a "guest" on order to by-pass the rules. This rule also affects ROD members who "share" the same RV but are not married to each other. Member will own only one membership of any kind or kinds. If a couple, or two members, which jointly hold a membership become separated, they must indicate in writing signed by both members, within 30 days, which joint holder will continue to hold the membership. Failure to notify Benjamin's Beaver Creek within 30 days of separation will lead to suspension or cancellation of membership.

# Responsibility for family members:

Members are solely and totally responsible for the behavior and conduct of their guests. All guests must be listed on the members; guest contract, by name, to be granted access to the resort. Guests must adhere to the same rules as the member. Members are totally responsible for acquainting their guest with the resort rules and are liable for any destruction of resort property by their guest. Guest may not use the resort without the member being physically present.

Members will be held responsible for any fine/fees or dues accrued by their guests or family members. Fines/fees or dues owed must be paid prior to the member's next visit. Members park privileges will be suspended until fees are paid.

#### Guest contract:

All expected guests are to be listed on the guest contract. Member is to read, date, and sign the contract. Guests not listed on contract will be denied entry into the resort.

# Day-use guests:

Guest may enter the resort as day-use guests of members. Including your own family; members may not have more than 10 persons in the resort under one membership.

#### Overnight guests:

Camp-in guests may stay overnight providing the member has reserved an additional site for their overnight guest-camper. There is a fee for the additional site. Night guest may not, in turn, have additional guests.

#### Guest vehicles:

Any vehicle overflowing onto the grass/street portion of the site must move to a designated parking area. Guest vehicles must have a vehicle pass displayed in such a manner that can be easily read at any time. Guest must deposit their vehicle pass upon final departure in the receptacle provided.

# Maximum usage:

No more than 10 people may be in the park at any time under one membership. Car-pooling is encouraged. Vehicles at your site must be limited. For example, your camping unit, two vehicles and guest car, but any other visitor cars must park in designated areas, and only if site can accommodate. Group camping information is available at the office.
